However, there is a lot going on behind the scenes planning and prepping for the upcoming Slavnost/Mayfest event at the Fairgrounds on May 19th in conjunction with the TCHCC. The Tribute Ceremony at 10:30 AM, Chicken Dinner at 11:30, and Happy Dancing Music till 4PM. Visit the Museum during this time to see all the upgrades as we continue to follow the museum's mission to "Preserve, Promote and Educate Polka Music and Dance". We're hoping to have the sidewalk completed from the bridge to the front porch and possibly all the way to the Salas House. Things don't happen fast but the planning, preparation of specifications, solicitation of bids, and then construction. We continue to develop videos/stories of the instruments

For those of you unfamiliar with this term, it will allow access to the Museum and Hoelscher Haus to anyone during working hours and weekends without us having to be onsite. Tour busses arrive from local cities to visit the Czech Village and we want to be able to show our museum to all when in La Grange. We have been working at the museum on weekends, and people from out of state stop by and ask if they can browse. This happens often! Although we cannot always *physically* be there when the need occurs, this will allow entry to the Museum. Motion lights, fans and A/C will be turned on via the internet allowing visitors to *virtually* enjoy all of the historical items and information on site.

Of course, we have cameras and surveillance 24/7. While this would not deter evil doers, history has been on our side for the past 20 years. The "Virtual Docent Program" will also allow opportunities to pursue additional grants from organizations who only consider granting funds to organizations open weekday and weekend hours. Bernard Frank Ripper September 1, 1931 - December 6, 2023

Bernard Frank Ripper, a U. S. Veteran passed away December 6, 2023 at the age of 92. He was born September 1, 1931, on a Middle Creek Farm between Ammannsville and Schulenburg on the Navidad River to his parents, Henry and Mary (Schmidt) Ripper.

Bernard was an only child until his sister, Marie, was born in 1943 and his brother, Francis, came along in 1946. Bernard walked three miles a day barefoot to attend Saint Anthony Middle Creek School. He also attended Saint Mary's School in High Hill and then

attended Schulenburg High School, where he graduated in 1950. From a young age, Bernard was a talented and gifted carpenter. In high school, Bernard's FFA team won first in the state for farm skill carpentry demonstration. Bernard also helped his parents in the fields doing farmwork. At the age of 14, he began working with his father and uncles. Bernard and his father worked alongside each other for many years building houses. After his father's retirement, Bernard became the sole owner of Ripper Construction Co. Bernard's son Michael, after his graduation, joined the business, and they worked alongside one another for many years.

Bernard met Lillian Marie Menis at a dance in Ammannsville. Bernard and Lillian were united in the Holy Sacrament of Matrimony at Saint Cyril and Methodius Catholic Church in Dubina, Texas on December 29, 1963, and were married by Bernard's uncle, Father Robert Schmidt. After their marriage, Bernard and Lillian lived in Dubina for 9 years. Bernard and Lillian were blessed with two children, Michael and Michelle. In 1973, Bernard and his family moved into the house that he and his father Henry built 2.5 miles east of Schulenburg, also known as "Birdhouse Hill", which is the same house that Bernard lived in for the rest of his life.

Bernard always loved to listen to Polka music along with calling in the rain report to KVLG. Bernard and Lillian were married for 58 years. Bernard worked with carpentry until his late 80's and he had a sharp mind his entire life. Bernard was a good boss that always was kind to his employees, many former employees had expressed to both Bernard and his family about the positive impact he made on them. He was able to remain in his home due to the good care he received from his son Michael. Bernard was a great father and grandfather who was committed to his family and his Catholic faith. He was hardworking, comical, kind, and honest. He was a just man.

Bernard is survived by his son, Michael Ripper of Schulenburg; daughter, Michelle and Milton Urban of La Grange; grandchildren, Joseph and Caitlin Urban, Matthew Urban, and Amanda Urban; sister, Marie and Firmin Hickey of San Antonio; and brother, Francis and Jan Ripper of High Hill.

He was preceded in death by his wife, Lillian; and parents, Henry and Mary Schmidt Ripper.

Services were held at St. Rose of Lima Catholic Church in Schulenburg. on Wednesday, December 13, 2023, with interment in St. Michael's Catholic Cemetery in Weimar.

Molly Cernosek July 15, 1932 to January 28, 2024

Born on July 15, 1932, to Frank and Amalie (Korenek) Machala, Amalie Martha "Molly" Cernosek, 91 years young, left this life on Sunday, January 28, 2024.

Family and community-oriented, her own unique brand of benevolence and integrity permeated her business and personal interactions, and we were all touched by her distinctive character. Excerpts of Elaine Thomas's 2020 article in the Fayette County Record are included here because they portray Molly's spirit so perfectly.

Molly was raised on a farm in Plum, Texas, and that's where she honed her strong work ethic, performing daily chores alongside her siblings that were not glamorous but essential to their way of life. At 16, Molly replied to an employment ad, and a family from the River Oaks section of Houston hired her as a nanny, which Molly characterized as quite "uppity living" for a farm girl. The best kismet intervened in 1949, when both Molly and Richard Cernosek attended a wedding dance in Houston, and the dye was cast! The twosome returned to build a life in Fayette County, becoming "The Cernoseks" on July 12, 1952, at Plum's Sts. Peter and Paul Catholic Church.

Molly and Richard were the ultimate entrepreneurial team and were quite expert at identifying good opportunities. Their businesses ranged from gravel mining to milk hauling to the Mol-Ric Motel, a brainchild of Molly's. Molly set a fair rate for the rooms and did all the cleaning herself. Land and property development proved to be the couple's sweet spot, and it's impossible to drive through the County and not see a property that the couple didn't have a hand in turning into an asset. Molly passionately cared for her community, volunteering with the Fayette Memorial Hospital Auxiliary, the La Grange Associates of Seton Development Board, and the Second Chance Emporium. Molly and Richard, both of Czechoslovakian ancestry, actively supported the Texas Czech Heritage and Cultural Center.

Surviving Molly are her children, Chris Cernosek and his wife, Lisa, of La Grange, TX, and Carmen Cernosek of Austin, TX; granddaughters Bailey Steinhauser and husband Matt of Forney, TX, Chelsea Kmiec and husband Tate of Bellville, TX, Carrie Binford of La Grange, and Danielle Holzheuser of Bastrop, TX.

Mardi was born on February 15, 1934 and raised on a family farm located near the Czech community of Praha, Texas. Her early education was in a small three room school house in the community of Novohrad, Texas. She attended Flatonia High School and graduated in 1951 as the Salutatorian of her class.



After high school she worked as a receptionist in a doctor's office. On June 13, 1954 she married Willie Kopecky at the Praha Catholic Church, one of the Painted Churches in South Central Texas. Mardi traveled with Willie as they served 20 years in the Air Force, having moved some 16 times. She was a real trooper and handled all challenges extremely well. She also donated countless hours to volunteer work such as the 1886 Room and the Caring Place. She was easy to like and easy to love.

Mardi and Willie adopted two boys, Michael and Christopher in 1963 and 1964. A girl, Sue, was born to them in 1966. She was a proud and loving mother to her three children and four grandchildren.



Edward Thomas Leech April 28, 1936 to January 30, 2024

For Ed Leech, life had meaning to his last breath. With the disease Primary Progressive Aphasia, he faced his challenges and fate with courage. Even though he was unable to move his body or to communicate with words and memory, he would whistle and continue making those around him feel happy, as he had done throughout his 87 years. His lifetime of kindness to others gave him a happy heart. He never wanted to burden family and friends with the trau-

ma of his disease. He died Tuesday, January 30, 2024.

Ed's jokes will be missed but more than that-his love of life, history, faith and, his devotion to his "Men for Others," by teaching morality of loving relationships to high school classes, keeping his 1954 high school classmates together with fraternal bonding that exists today, joining and participating in Rotary for service to community from 1960 until this past year, volunteering for the International Executive Service Corps in Cairo, Egypt, and introducing the Third World Lost Boys of Sudan to the First World of Dallas. They called him "Baba."

For work, Ed was an AT&T manager, a stock broker, a banker, and a captain in the Army Reserves. For sports, Ed was a young diver and gymnast, who walked on his hands into his 50's. He was an avid fan of most athletics.

For special fun he was commissioner of a fantasy basketball team, avid collector of stamps and coins, enthusiastic golfer, Colorado hiker, supporter of live theater (especially his wife's Czech family heritage story-"Heart of the Tin Trunk") and traveler of all seven continents. He made time to be a CASA volunteer, an arbitrator for the National Association of Securities Dealers, an early organizer of an entertainment series for the city of La Grange, as well as a Junior Achievement volunteer in public schools.

A devoted family man, he is survived by his wife of 63 years, Virginia Mika Leech of La Grange, Austin daughters Kelly McGill and Dana Wills and her partner Phillip Engle. Also, from Austin are grandchildren Austin Wills, wife Allie Nicholson, and great granddaughters Charley and Margot Wills, both with whom he had a special bonding; from New York, grandchildren Allison Wills and her partner Steve Lillegard, and Conner McGill;. and close friend, Susan Kim Shaffer of Austin. He had numerous nieces important to him, especially Darlene Leech of Arlington and Beverly Leech of Los Angeles, California and many special nephews, nieces and cousins, especially Carol Peters of Austin. His friends were important to him. Among them were his '54 Jesuit classmates. Preceding Ed in death are his parents, Paul and Katherine Leech, and two brothers, Paul and John Leech.


